Plug-in Pest Repeller, 9815

Please read these instructions carefully before use and retain for future reference.

- The ultrasound waves cause discomfort to rodents, cockroaches, ants, spiders and other unwanted bugs and pests.
- The electromagnetism works by changing the surrounding energy field emitted by the wiring in the home which irritates pests, driving them away.
- Suitable for use around people and most household pets.
- Does not affect computers or other household appliances.

HOW TO USE

- Plug into the mains.
- The red light indicates the electromagnetic function.
- The yellow light indicates the anion function.
- The green light indicates the ultrasound function.
- All 3 lights illuminated together indicates that the electromagnetic, anion and ultrasound functions are working.
- The 3 LED indicator lights will illuminate in turn and the night light will illuminate.
- Pressing the switch once to select electromagnetic mode. This mode works intermittently for 25 seconds then pauses for 35 seconds.
- Press the switch again to select the anion mode. This mode works for 5 minutes then pauses for 20 minutes.
- Press the switch a third time to select ultrasonic mode, which has frequency between 25-65KHz.
- Press the switch again to select multi-function mode, where all 3 modes will operate at once.
- The unit covers an area of up to 200m².

WARNING

- Do not use if you have pet rodents (such as hamsters, guinea pigs, etc.), rabbits or spiders as the unit may cause them discomfort.
- When first using the unit, it is normal for pests to become more active as they try to escape the discomfort given off by the unit. Allow 1-3 weeks for full effect of the unit to be seen. Some cockroach species are more resistant to the effect of the unit than others so these may take longer to drive away.
- Where possible, leave a window or door open as an escape route for unwanted pests. However, take care to remove this escape route once the unit has taken effect so as not to allow new pests to enter.
- Keep away from water and other liquids.
- Do not use in combination with poisons or chemical products as these are designed to bait pests and will attract them, negating the effect of the unit driving them away.
- For indoor, domestic use only.
- Internal walls, doors and other obstructions can reduce or restrict the operating range of the unit.
- The unit is not intended to be operated by means of an external timer or separate remote-control system.
- This unit should not be used by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning use of the unit by a person responsible for their safety.
- Do not leave unattended for long periods of time.
- Do not use in exteme humidity.
