



### Save energy and electricity

These remote control sockets enable you to turn your appliances on and off remotely. It saves you time, effort electricity and money.

The remote control sockets are great for hard to reach sockets under furniture or behind TV's and microwaves.

### Setting up:

- Your pack contains 3 sockets (receivers) and 1 remote control.
- Insert 1x 23A/12V alkaline battery (not included) into the battery compartment of the remote control
- Plug the sockets into a desired power outlet.
- The remote control has three group buttons with numbers 1, 2 and 3. The three receivers also have a number on each, '1' on receiver 1, '2' on receiver 2 and '3' on receiver 3. So button 1 on the remote control, controls receiver 1, button 2 controls receiver 2 and button 3 controls receiver 3.
- To turn on any of the receivers simply press the 'On' button under the corresponding number on the remote control.

- To turn off any of the receivers simply press the 'Off' button under the corresponding number on the remote control.

### **Trouble Shooting:**

If the socket does not respond to the remote control please check the following:

- The battery may be low. Check the battery and replace if necessary.
- The distance between the remote control and receiver may be too great, the maximum transmitting distance is 30 metres. Move the remote closer to the receiver if the distance is greater.

### **WARNINGS!**

- For indoor use only.
- Do not exceed the maximum load current of 10A.
- Avoid exposing to high temperatures, sunlight or moisture.
- Do not use the receivers together via the same power socket.
